MINUTES

March 24, 2008

1. Call Meeting to Order

c. Chamber of Commerce Lease Renewal

The Chamber of Commerce has come forward with a proposal for a 6 month extension of the current lease and will pay half of the yearly lease amount along with the property tax.

d. Town Building Committee Interim Report

Chairman Rob Corson from the Town Building Committee presented the preliminary report of progress to the Board. The presentation included a review of the resident and staff survey and site visit information and the next steps of the committee. Mr. Corson spoke of visiting four different communities; Dover, Londonderry, Derry and Portsmouth, to observe their operations and space utilization. He stated that the visits were very informative. There was a preliminary concept floor plan for the reorganization of the building reviewed by the board. The plan is to add offices and to lessen the traffic flow on the first floor. The final report will be presented in May.

e. Board Priorities Discussion

Selectman Pace brought up the priority issues in town that need attention. There was a discussion on who would step in to take care of these certain issues. The major issues that needed attention were Finance, Personnel, Contracts and Agreements, Infrastructure, Board / Town Manager and IT. Mr. Dean also brought up the Down Town Project and the Parking Garage.
