Russ Dean: There are two easements being worked on as of now. When the mapping of the waterline is complete, the projects will be passed along. The Town Report is being focused on and is to be sent to the printer by February 13th. A near finally tally for the FEMA storm in December is \$100,000. Mr. Dean will be meeting with FEMA representative Monday to go over the reimbursement process. Mr. Dean had the chance to testify on a bill last week to name the Guinea Road Bridge after Senior Chief Officer Dan Healy. He also testified on legislation for the Board's ability to lease Town property for up to 5 years if the town should so vote. Mr. Dean attended the Municipal Managers Meeting where they heard from the Department of Revenue and the Department of Transportation.
