NOTES:

All Planning Board Applicants must first go through the Technical Review process. An Applicant will **NOT** be scheduled for a public hearing before the Planning Board until the Technical Review process has been completed. If a Technical Review is not required (e.g. Minor Subdivision, Lot Line Adjustment, Conditional Use Permit), an Applicant will only have to adhere to the “Re-Submittal Date” column for initial submission of such an application.

Technical Review Committee (TRC) meetings are held in the Wheelwright Room on the first floor of the Town Office Building. Planning Board meetings begin at 7:00 P.M. in the Nowak Room of the Town Office Building, 10 Front Street, Exeter. The Planning Board meetings are also televised on Cable Channel 22 (EXTV).
