EXTV-P USE CONTRACT (PART OF PRODUCER AGREEMENT)

1. I certify that I have read and agree to abide by the EXTV-P Access 98 Policies and Procedures Manual ("Manual") of the Town of Exeter, acting by and through its Cable TV Advisory Committee and EXTV-P.
2. I certify that I have obtained all necessary legal rights and clearances from any and all persons featured in the program and for copyrighted material, and have permission to broadcast video and audio of said persons and any such copyrighted material over the cable system, pursuant to the requirements specified in the EXTV-P Manual.
3. I have provided above the name, address and phone number for any sponsor, person, or organization which has contributed toward the production. I further agree to identify said sponsor, person, or organization, as well as, the producer at the opening and/or conclusion of the program.
4. I agree to submit a program outline, script, or videotape for review in accordance with EXTV-P Policies and Procedures. I understand and agree that EXTV-P may reject any or all video or audio portion of the material I submit if it is deemed to be prohibited by the EXTV-P Manual.
5. I assume full responsibility as the producer and/or program originator/sponsor for the program to be broadcast on EXTV-P. I agree to indemnify and hold harmless the Town of Exeter, its officers, employees, volunteers, and the cable provider for any and all claims made in association with the material supplied by me for access programming. I further assume all liability including attorneys fees, for claims alleging violation of copyright, trademark, patent, literary rights, dramatic rights, rights of privacy, and libel/slander laws. I acknowledge that EXTV-P reserves the right to participate in any action arising from the broadcast of the program and that I and/or my counsel will fully cooperate with EXTV-P, the Town of Exeter, or its attorney(s).
6. I agree to hold harmless and release EXTV-P from any claim which may arise from the cable casting of the program, or any mistakes, omissions, interruptions, delays, errors, or defects in the transmission of the program.

7. I agree to provide promotional items to help create an audience for my program. Such promotional items may include but are not limited to: a 30-second promotion for broadcast, a news press release, and/or copy for the EXTV-P Bulletin Board.
8. I understand and agree that each statement in this contract is not considered a personal agreement between me and any EXTV-P representative or Town of Exeter Cable TV Advisory Committee member, employee, or volunteer, past or present. Any claims which can be or have been made against such individuals are waived in this contract.
9. I understand that this contract and any associated attachments will be maintained in EXTV-P files for a period of two (2) years and will be made available for inspection to any interested parties.
