Good afternoon Andrew,

I'm the Maine Land Protection Project Manager with Trust for Public Land. We are currently in the process of applying for a Land and Water Conservation Fund (LWCF) grant to support the acquisition and creation of the Newfields-Exeter Community Forest. This grant funding would support the larger 148-acre project and expand the existing town forest land in Newfields and Exeter. This project would create hiking, biking, and walking trails, expand upon existing public recreation opportunities in the area, and form part of a 1500 + acre block of "Unfragmented Forest" designated by state Wildlife Action Plan.

As a large part of the conservation, we believe that an endorsement from the Exeter Conservation Commission through a Letter of Support for this grant would strengthen our application. To be clear, this grant would **not** apply to the Exeter side of the land acquisition, but would support the larger project. If you are willing to show support for this grant, we would encourage you to add your own perspective on why the Exeter Conservation Commission supports this Community Forest Project. Feel free to use the attached LOS template to incorporate any language about the project. I also included a project overview to provide additional context. If you are able to send us a Letter of Support by some point next week that would be much appreciated.

Introduction of Members Present (by Roll Call) 11 12 Present at tonight's meeting were by roll call, Chair Andrew Koff, Dave Short, Nick Campion, Kyle Welch, 13 Keith Whitehouse, Alternate Valerie Fanger, and Alternate Michelle Crepeau. 14 15 Staff Present: Kristen Murphy, Conservation and Sustainability Planner 16 17 Mr. Koff called the meeting to order at 7:00 PM, introduced the members and activated all of the 18 alternates. 19 20 2. Public Comment 21 22 There was no one from the public present outside of agenda items. 23 24 **Action Items** 25 26 1. Webster Ave Pump Station and Force Main Upgrade (Britt Eckstrom, Wright Pierce) 27 28 Britt Eckstrom of Wright Pierce presented the application of behalf of the Exeter DPW for 29 recommendation to NH DES for a Wetland Permit Application to upsize the existing pump station to 30 meet the current and future demand. There will be 7,747 SF permanent and 7,400 SF temporary 31 impacts to the tidal buffer and within the highest observable tide line. 32 33 Ms. Eckstrom indicated the 8" force main will be replaced with a 12" main and there will be a 24" 34 culvert replacement in the same location. She described the planned demo of the existing pump station 35 once the replacement is complete and the planned replacement of the generator. There will be new 36 pavement for a turnaround for emergency vehicles and equipment. The lot site is within 100' of the 37 tidal buffer. She described restoration with loam and seeding and protection methods during 38 construction such as silt fence and sock and monitoring. She noted that Marc Jacobs, a wetland 39 scientist, delineated the site. There are some freshwater wetlands which are not impacted. Impact to 40 migratory birds was discussed but determined there was no tree clearing and they will not be nesting in 41 the construction area. There is no clearing in the new paved area.

The Commission discussed the potential for sea level rise and Ms. Eckstrom indicated the design is for 3' above for critical infrastructure based on design guidance. She noted the DES guidance looks at the lifespan of the structures, which in this case is 50-75 years.

Ms. Eckstrom described the timeframe for the project as a two-year duration starting in spring and finishing in the summer of 2025.

Mr. Campion asked about the timeline coinciding with the Golf Course project across the street and Ms. Murphy indicated DPW would coordinate that.

Mr. Koff motioned that the Commission has reviewed the application and has no objection to the application as proposed. Mr. Welch seconded the motion. A vote was taken, all were in favor, the motion passed unanimously.

Mr. Koff indicated he would send a memo to the state.

2. Committee Reports

a. Property Management

Ms. Murphy reported on Raynes Farm construction and what items had been completed and those were need to be completed such as clapboard and trim which Mr. Bedford will not finish this year. Some interior work can be done such as the second layer of flooring. She noted acceptance of the \$20,000 Moose plate grant application and application for the \$50,000 Hometown Grant from T-Mobile which will be determined in February. The Moose plate grant funding will be available for two years. The Town deferred the project for at least a year. Ms. Murphy noted the remaining cost is \$76,000 less the \$20,000 for the Moose Plate grant so \$56,000.

Ms. Murphy reported the mowing has been done. Mr. O'Hearn discovered a lean to near the Cole Property. There have been several hunting issue calls which can be addressed with signage.

Ms. Murphy noted she was somewhat behind on monitoring and some of the members volunteered to help.

Ms. Murphy reported that Sig Sauer volunteered time helping with bridges and planting.

b. Trails

Ms. Murphy reported signs were posted along the brook and Eversource has put up caution tape where they are working.

The Commission thanked Mr. Whitehouse for his work cleaning up the trails on Continental and Allen Street.

87 88	Ms. Murphy noted there used to be a trailhead marker and recommended 4x4 posts at the trail could be a good project they could do.

92	Ms. Murphy and Mr. Welch recommended a bird counting event seasonally with a point system for
93	unique bird identification and photographs. Ms. Murphy will add Mr. Welch as a contributor and
94	launch the contest in January. Mr. Campion noted the Merlin app was a good tool to identify birds
95	by sound.

99	Ms. Murphy reviewed the Ryder and Rugg Property grant applications and site walks in November.
100 101	There are some issues with land owners and titles.
102	Ms. Murphy and Ms. Fanger attended the NHACC conference and discussed some interesting
103	funding done by East Kingston who did a \$4 million bond article over 20 years which will allow them
104	to bond as needed and not have to wait for town meeting for every project.
