TREE COMMITTEE

DRAFT MINUTES FOR MAY 13, 2025

I. PRELIMINARIES:

BOARD MEMBERS PRESENT: Eileen Flockhart (Chairwoman), Steve Jones, Niko Papakonstantis (Selectboard Representative), Deb Twombly, Sally Ward, Gwen English

STAFF MEMBERS PRESENT: Kristen Murphy, Kirk Scamman

II. CALL TO ORDER: Chair Flockhart called the meeting to order at 8:35AM

III. OLD BUSINESS: Minutes from April 8, 2025, approved without changes.

IV. NEW BUSINESS:

Eileen gave a quick review of the Alewife Festival which was held in the Town Hall from 10:AM-1:PM on Saturday, May 10. All felt that it was a success in spite of the rain.

Eileen then reported to the committee members on the saga of the missing Sweet Gum Tree at Lincoln Street School. Upon discovering that the tree was gone and yet the granite post and label were still in place, she contacted Rusty Lyster to find out more about the tree's removal. Apparently, there was considerable damage done on and around the playground equipment and the school decided to install security cameras with the hope of catching the individuals responsible for the damage. The Sweet Gum tree blocked the needed view and was subsequently removed. (It was also said that the tree never leafed out, so perhaps it was not in good health, or was dead). There are 3" caliper Sweet Gums available at the Stratham Circle Nursery, and the School Department will pay for the replacement. We need to make a decision about where the tree will be planted. Eileen feels it is important that this be a group effort, and all need to take responsibility for the new tree's health. Kirk Scamman volunteered to be responsible for contacting Dig Safe and will also dig the hole for the new tree once a site has been selected.

Following this discussion, we agreed that we need to review our list of trees, and committee members will sign up to monitor them. (And we should assign that task to a member every time a new tree is planted.)

Gwen suggested that perhaps we could contact Keith Schmitt and Katy Pupino (Green Team teachers) and see if their group could monitor the health of the trees.

Kirk indicated that his office will be receiving two iPads in the next two week, and they will be available for DPW to use to update the condition of trees. They can update the site as they plant trees.

Eileen wondered if anyone knows where the Tree City stickers are that go on the wooden plaque that we received.

Eileen and Kristen worked on the web page and are making improvements to the website which has content but there is 'button space' for pictures and text. This is a work in progress!

Gwen asked about the rocks placed around the trees on the YMCA site. The rocks will absorb heat and ultimately that heat will also heat the roots of the trees. Deb Twombly said she would speak to someone at the Y about this and will encourage them to remove the rocks and replace them with non-dyed mulch.

Kirk was asked about the status of the water tank, and he indicated that it is still being worked on. DPW is short staffed!

Deb asked if we have money available to purchase tree diapers. We have \$20,000.00 but once we buy trees and cover costs of tree removals etc. the money will be spent quickly. (Deb will look into the cost of the tree diapers.)

Eileen reported that Stratham Circle Nursery is still holding trees for us (A lilac and a Cherokee Brave Dogwood), but we probably won't re-position the Herbie Elms that are at the library until fall. (September or October), therefore the lilac and the dogwood will not be planted until after the elms have been relocated.

Will get updates from Greg Bisson about the playground schedule. Kirk wonders if we want to get the trees in before summer camp starts, or, following Steve's advice, perhaps we should wait until fall when stresses of summer don't become challenging. Kirk and Greg will work all this out. (Perhaps we could do all the trees at the same time! Library and Recreation building!)

We then discussed the labeling of more trees at Town House Common, Swasey Parkway and Brickyard Park. Steve, Sally and Gwen have agreed to walk those sites

and try to determine where labels could be placed. (Sally says only two are needed at Brickyard Park.). Kirk says that Jay has the granite for posts.

Deb Twombly updated the committee on the progress of the FUUSE project. They have moved granite and are looking at a 3,000 square foot area for a mini forest with a path. (A meditation garden with a bench is also part of the project.) They are raising \$20,000. outside of the church budget to make all this happen. This is following the Akira Miyawaki (Miyawaki Method) plan for a self-sustaining ecosystem. Once this has been established, it will be a wonderful template for future mini forests in Exeter. (i.e. at the High School)

Eileen summarized the work done recently at Peter Waltz's house where committee members and others packaged up and labeled nearly 200 little Fraser Firs for Lincoln Street School students.

Kristen Murphy and Eileen introduced our guest, John Cerullo, a representative from NG Gilbert Utility Line Services. NG Gilbert is working with UNITIL in part to determine where hazard trees are located under or near utility lines. Mr. Cerullo attended our meeting as required to comply with our Tree Ordinance. There are four trees that exceed 20" caliper dimensions that need to be removed. He needs our approval before NG Gilbert can do any work. Steve Jones moved that we grant our approval for the removal of four specific trees, Sally Ward seconded his motion. All committee members voted in favor.

Kirk mentioned a large dead pine tree at the end of Garrison Lane. It will come down and will be left in place to rot.

Meeting adjourned at 9:40AM
