- Proposed Legislation, Solar Exemption Discussion w/ Tax Exemption Cmmte- Julie
  Julie not present; Julie sponsoring bill to create revolving fund; discussion of this topic tabled until next meeting.
- 5. October 24 Styrofoam Collection Event (9-11a)
  - Event is sufficiently staffed, but volunteers are still welcome
  - If anyone is willing to volunteer, show up around 8:30; no sign-up necessary
  - Event is at Public Works facility
  - Kristen to send Abby flyer to post on EHS Environmental Club Instagram
- 6. Window Dresser Program Exeter Build for 2025-26
  - Currently have 20 orders so far about 195 windows
  - Measuring has started measuring team is sufficiently staffed
  - Continuing outreach to spread the word about WD to resident-owned communities
  - Gaining support from other communities Stratham, Brentwood, East Kingston
  - Engaging multiple groups for financial support
  - Both Cliff and Stephanie are traveling 11/1-11/10 will likely need support during that period
  - Stephanie to map out timeline to determine when orders need to be placed
  - Social media is very helpful for building awareness and engagement

- Seeking speakers to come speak to the club
- Kristen suggested investigating NHEEP grant program provides grants up to \$1000 to create excitement around a specific action; potentially could support a program such as getting EV chargers at EHS
- Suggestion to invite new facilities coordinator to next club meeting
- 8. EECBG project (Jack Frost) Update Kristen
  - Continuing to make progress despite federal government shut down; DOE staff furloughed
  - Biggest hurdle is getting contractors registered through portal; creates administrative challenges for contractors
  - Total grant is \$200k but there is flexibility around the number of homes and \$ per home that can be allocated

- Home audits are ongoing but construction is slow to get started
- The project will have major impacts for the customers

  - Comments from attendees:
    - Seemed to lack content geared towards local committees; suggestion to provide input to organizers to engage local committees or add a track for local energy committees
    - Clean Energy NH had a checklist for what clean energy committees could tackle

    - Amy inspired to reach out to town businesses to discuss support for EV chargers
