#### **GENERAL SUMMARY:**

Under the direction of the Plant Senior Operator, performs technical and maintenance functions associated with wastewater treatment facilities.

# **ESSENTIAL JOB FUNCTIONS\*:**

- Responsible for the efficient and effective operations of the wastewater treatment plant during an assigned shift.
- Maintains appropriate local, state and federal report forms in accordance with rules and statutes.
- Maintains daily operations logbook.
- Acquires appropriate wastewater samples and conducts test procedures, as required.
- Maintains wastewater lift stations daily/weekly and assists Water & Wastewater Maintenance Technician at times as required.
- Monitors and adjusts SCADA apparatus in accordance with appropriate procedures.
- Inspects plant equipment and machinery, making adjustments as needed and performing proper cleaning and maintenance tasks.
- Continues to maintain wastewater preventative maintenance program for lift stations.
- Performs bi-annual grease trap inspections

### OTHER DUTIES AND RESPONSIBILITIES:

- Operates hand and power tools as necessary.
- Adheres to Town's written operating procedures and policies.
- Performs other related duties as assigned.
- Must be available for holiday and weekend hours.

# PREPARATION, KNOWLEDGE, SKILLS & ABILITIES:

Duties require knowledge of wastewater treatment systems and operations equivalent to
completion of a high school diploma along with advanced courses from a two-year college or
technical school, and one to three years of related experience, or an equivalent combination of
education and experience. New Hampshire Grade I license for Wastewater Treatment Plant
Operators, Class II preferred; hold, or obtain in one year, and a NEWEA Class I Lab
Technician Certification.
