## **Organization Profile:**

Incorporated in 1983, One Sky Community Services is dedicated to *assisting people with developmental disabilities or acquired brain disorders to live as valued and participating members in their communities.* Honoring the inherent value of every human being, we are committed to:

- Helping people make choices about where they live, work and spend time
- Using all existing resources possible to create and maintain support services that are flexible and responsive to the needs of each individual
- Assisting families in ways to maximize their support for the individuals we serve
- Promoting community understanding, acceptance and support for individuals with disabilities
- Fostering the inclusion of those we serve in community relationships and affairs
- Working together with citizens, professionals, and partner organizations to realize our mission

One Sky is required to operate under state-mandated rules and regulations, and is the initial point of contact for any individual with a developmental disability or an acquired brain disorder requiring support and/or assistance within our service area. We determine eligibility for available funding, work with eligible individuals and their guardians to identify specific service needs, suggest a variety of possible service providers, help the individual and guardian decide which ones to select, and monitor the quality of care. Through our One Sky *Futures* organization, we also provide direct services, including long-term housing options.

Since 1983, with only a handful of individuals transitioning out of the state's institution (Laconia State School), and relatively few dollars, we have grown into a comprehensive service agency serving individuals and families yearly.

From birth to age 3, we provide early supports and services to infants and children with developmental delays or established conditions such as Down syndrome. From ages 3 through 21 we help the families of children with developmental delays and disabilities obtain services and supports to ease the burden of caretaking and enable their children to participate as members of the community in the fullest way possible.

Once an individual turns 21, we work with them and their family/guardian to develop a plan for long-term support that, in most cases, will allow the person to live as independently as possible in their own community. Day services may enable the individual to remain in their own home with a family member who goes out to work, or in some cases, independently. Another option is placement with a state-certified "foster" home care provider, supplemented by in-home or community-based day services. We may also place an individual in a small group home with round-the-clock supervision.

The people we serve – our "clients" – currently receive all of these different kinds of services, either through our One Sky *Futures* service provider or the 18 major service provider partners with whom we work.

#### Exeter residents we serve:

Being the sole resource of Medicaid for those with Developmental Disabilities who live in Exeter, our influence on their lives can be impactful not only on the quality of their life, but in terms of the comprehensive level of services and supports we provide to them. Although the people and government of New Hampshire have been supportive of our efforts to protect and expand the rights of the people we serve, competing public policy and budget priorities are starting to place the resources available to us at *significant risk*. These cuts are occurring exactly at a time when the needs of our target population are snowballing.

- The number of children diagnosed on the autistic spectrum is increasing
- Children who are turning 21 and eligible for our services is increasing
- The number of individuals with developmental disabilities who are dealing with significant behavioral health and/or substance abuse issues requiring very specialized and intensive (i.e. expensive) services is increasing
- Our population has aged and their needs have changed, the state and federal dollars available has not kept pace
- There is a growing shortage of long-term housing options for the people we serve......resulting in individuals such as the young man from Exeter who was recently forced to stay in the emergency room of Exeter Hospital for an extended period of time

Many of the services and supports One Sky delivers are unique and cutting edge for human services. Exeter clients and their families are very supportive and pleased with what we provide. They look to us for solutions and to assist them with emergencies, as well as with crucial and essential needs. One Sky will do whatever it takes to meet the needs of those living in Exeter through advocating for change at the state level, fundraising, meeting with community leaders, and much more.

The number of clients that live in Exeter include young children and young adults, as well as older adults and seniors. One Sky provides all of them with a broad spectrum of services, such as:

- Vocational services, residential supports, day activities, and money management programs
- For those on the Autism Spectrum and/or with a disability that impacts behavior, we provide them with everything from initial assessment to direct therapies, school consults and parent trainings
- Resources for children, from birth to three years, and their families that include developmental evaluations, therapeutic interventions, guidance, instruction, referral to community resources, and emotional support
- Information and support to families that have a member with a developmental disability living with them, working directly and in partnership with other community organizations to provide the education, information and personalized supports needed
- For seniors and adults with disabilities who need social and cognitive stimulation and require health monitoring during the day
- Through their Service Coordinator, individuals and families can manage their own budget, hire their own workers, and plan daily living needs and social/recreational activities
- Addressing the needs of families with children, from birth to age 21 years of age, with chronic health conditions, utilizing a family-centered approach

With so much at stake for these individuals and their families, One Sky Community Services must continue to provide the full range of services that are so indispensable. In order to do so, it must secure new supplemental and dependable funding sources. While our budget may seem large, Medicaid still does not cover everything our clients need, and our agency is facing a growing number of individuals to whom we cannot provide long-term supports right away but who still require short-term assistance while they wait for funding to be available to them. This is a statewide issue that is not going away and is being lobbied hard in Concord.
