The Society of St. Vincent de Paul Exeter Inc. (SVdP) is applying to be included in the 2018 Human Services budget. SVdP is requesting \$10,000.00 in funding equivalent for what is required to operate the Community Assistance Center for 1-1/2 weeks. The funding will be used to purchase food for the food pantry, provide housing payment assistance and dental care assistance for Exeter residents.

#### Background

SVdP operates with 170+ volunteers of many faiths. The Board of Directors and executive officers are also of many faiths. SVdP has a paid Executive Director and two part-time staff members.

SVdP's mission at the Community Assistance Center (CAC) is to provide emergency food and assistance to those in need who have exhausted other available resources. We work closely with Sheri Riffle, Human Services Administrator, to coordinate the needs assessment and resulting client assistance required. Exeter residents account for 92.4% of our clients.

SVdP provides free office space for the convenience of Exeter residents to NH Employment Security, CAP (Rockingham Community Action – homeless outreach & fuel assistance), VITA (Volunteer Income Tax Assistance) and Families First (medical van and Medicaid enrollment).

SVdP is a New Hampshire non-profit corporation.

### What We Do...We Help People

Many activities and functions take place within the CAC to support our clients. Attached to this letter is the requested overview that summarizes the programs and services available at the CAC.

### Society of St. Vincent de Paul Exeter Overview

The Society of St. Vincent de Paul Exeter (SVdP) began serving the poor and hungry in Exeter in 1989. Located at 53 Lincoln Street, there is a paid staff of 2 full time equivalents assisted by over 170 volunteers. The Community Assistance Center (CAC) is open 5 days weekly with extended hours 3 days weekly.

Services and Programs offered at the CAC include:

- Food Pantry Emergency food is available to low income households. Clients visit the
  food pantry and choose items from our shelves, coolers and freezers including milk,
  butter, eggs, produce, bread and pastries, meat and poultry, nonperishable foods and
  personal care items. Special summer program is available for households with schoolaged children. Seniors are provided with a monthly dedicated senior pantry day with
  guest speakers and summer cookouts.
- **Dental Services** In collaboration with Families First, the CAC provides on-site oral health assistance, hygiene and dentistry 2 days weekly.
- Medical Services In collaboration with Families First, the CAC provides on-site medical assistance to the needy in our community 1 day weekly. A representative from Families First is also at the CAC to assist with Medicaid and health insurance enrollment.
- Substance Abuse Counseling In collaboration with Catholic Charities, the CAC provides on-site substance abuse counseling for the needy 1 day weekly. Referrals can be made to residential or long-term care.
- **Financial Assistance** Emergency financial assistance can be obtained after exhausting all other resources. Examples of financial assistance includes rent/mortgage payments, security deposit, car repairs, car payments, utility bill payments and prescription payments.
- Housing and Homeless Assistance The CAC can provide survival food, blankets, clothing, cell phone and put the homeless in touch with homeless assistance agencies and shelters. SVdP hosts a representative from Rockingham Community Action Program on Mondays to help anyone who is homeless or in an unstable living situation find shelter.
- Fuel Assistance SVdP hosts a representative from Rockingham Community Action Program on Thursdays to enroll low income residents in the heating fuel and electric assistance program.
- Employment and Computer Skills SVdP can help clients find employment through job listings as well as information on adult education and training classes. For those that would benefit, we can arrange for free one-on-one computer training. SVdP hosts a representative from the NH Employment Security office twice a month to assist with filing for unemployment benefits, employment searches and resume writing.
- Income Tax Preparation During the tax season, SVdP hosts IRS certified Volunteer Income Tax Assistance (VITA) volunteers for free tax preparation and filing.

#### **Program's Impact on Exeter Residents**

In collaboration with the Town of Exeter Human Services Department, SVdP assists with the fundamental needs of low income Exeter Residents. As noted in the application, 92% of the client households served by SVdP at the CAC are residents of Exeter. The Annual Reports (Fact Sheet 2016 and Fact Sheet 2017 YTD) quantifies the number of household visits to the CAC and the quantity of food received. The actual financial Profit and Loss for 2016 and the Operating Expense Budgets of 2017 and 2018 shows the cost of providing the services and programs. Referring to NH RSA 165 above with the explanations provided by NH Legal Aid, SVdP's expenses incurred in 2016 and budgeted for 2017 and 2018 have both a significant benefit impact to Exeter residents as well as a significant savings to the Town of Exeter's budget/assisted persons responsibilities.

Our assistance encompasses the guidelines as outlined in NH RSA 165 and by NH Legal Aid. NH RSA 165 (Aid to Assisted Persons) states: "Whenever a person in any town is poor and unable to support himself, he shall be relieved and maintained by the overseers of public welfare of such town, whether or not he has residence there.

NH Legal Aid expands on RSA 165 above as follows: "Towns and cities are required to provide financial assistance for basic necessities such as food, shelter, rent, mortgage payments, heat lights, gas, water, necessary clothing, transportation and prescriptions. Basic telephone service may be paid if necessary for health and safety reasons.

Towns must also help with "maintenance" items such as paper products, household supplies, diapers, etc. Towns should pay security deposits if necessary to obtain housing. Necessary medical costs should be paid if there is no other way to obtain essential medical services."

# Program Changes and/or Highlights From The Past Year

Significant changes and highlights include:

- Demand for dental services is expanding significantly with an 17% increase over the previous year..
- Demand for homeless assistance is expanding significantly and is benefiting from the partnership with the Exeter Police Department. Homeless assisted is 63% over the previous year.
- The dedicated senior pantry day has been very successful and may lead to additional senior services.
- Substance abuse counseling was introduced as a new program.

# Society of St. Vincent de Paul Exeter Another Year of Helping People - 2016

The following the recap of assistance to those in need that has been provided at SVdP's Community Assistance Center by the 200+ volunteers. Your help is needed more than ever. The cost of living is rising with food and housing topping the list. We witness the effects of tough times in the faces of our clients – the poor, unemployed and under employed including the working poor.

- Distributed over 357,600 pounds of food with a retail value of over \$1,075,000 during 3,162 Exeter area client household visits to the food pantry. That is over 310,000 meals. We offer a full selection of meat, dairy, produce, bakery, packaged food and personal care items.
- A dedicated monthly food pantry session with free transportation was established for seniors in June with an average participation of 24 senior client households per month.
- Provided emergency dental care and preventative dental hygiene care to 371 clients, many subsidized.
- Saved 14 households from eviction.
- Helped 76 families and individuals with various crisis assistances overdue utility payments, medical assistance, emergency housing and vehicle repairs and payments so people could continue to work.
- Assisted 56 families and individuals with financial counseling, budget balancing and resolution.
- Aided 77 homeless families and individuals with referrals to shelters, emergency supplies, food and transportation.
- Our Community Assistance Center offers office hours for NH Employment and Security, Fuel Assistance, Income Tax Preparation by VITA, Homeless Assistance, Families First Medical Van and the SVdP Dental Van.

# Society of St. Vincent de Paul Exeter Another Year of Helping People – Thru July 2017

The following is an interim recap of assistance to those in need that have been provided through July at SVdP's Community Assistance Center by the 170+ volunteers. Our fiscal year is the calendar year. Only through the support of donations and grants are we able to continue this effort.

- Distributed over 194,210 pounds of food with a retail value of over \$582,600 during 1,634 Exeter area client household visits to the food pantry. That is over 168,315 meals. We offer a full selection of meat, poultry, dairy, produce, bakery, packaged food and personal care items.
- A monthly dedicated food pantry session with free transportation was established for seniors in 2016 with an average participation of 25 senior client households per month.
- Provided emergency dental care and preventative dental hygiene care to 258 clients, many subsidized.
- Saved 6 households from eviction.
- Helped 42 families and individuals with various crisis assistances overdue utility payments, medical assistance, emergency housing and vehicle repairs and payments so people could continue to work.
- Assisted 42 families and individuals with financial counseling, budget balancing and resolution.
- Aided 85 homeless families and individuals with referrals to shelters, emergency supplies, food and transportation.
- Our Community Assistance Center offers office hours for NH Employment and Security, Fuel Assistance, Income Tax Preparation by VITA, Homeless Assistance, Families First Medical Van and the SVdP Dental Van.
