The KEY (KEY to Empowering Youth) Collective gives K-12 kids from low-income families in the Seacoast NH region easy access to sports and other youth activities for free, or at a reduced cost, with no red tape and no social stigma attached.

Decades of research have shown that being involved in extracurricular activities has numerous physiological, social, and physical benefits. Kids who are involved in activities outside of school on average have stronger mental health, do better in school, learn soft skills such as teamwork and leadership, and live healthier lifestyles. But not all kids have access to these life-changing activities.

This is where KEY Collective's #areuin? card program & scholarship fund come in. Kids qualify for an #areuin? card by being accepted into the Federal Free & Reduced Lunch program, NH's Medicaid program, or through a referral from a qualified, approved validator (ie. school nurse, social worker, doctor, etc.).

The #areuin? card is like an EZPass for all of KEY Collective's <u>program partner activities</u>. Once a family fills out the application and receives the card, the child is automatically qualified for the scholarships and discounts offered by 40+ partners that KEY Collective has a relationship with. No need to fill out more paperwork or ask the program for assistance. Each partner has a different registration process, but it's usually as simple as showing the card or providing the #areuin? membership number at registration. Easy and anonymous!

What we have learned over the past 8 years is that not only are we removing financial barriers, but we are educating families on all of the out-of-school opportunities that are available to their kids. Many of our #areuin? card families are so focused on meeting basic needs, that they do not have the time and/or bandwidth to try to figure out what opportunities are available to their kids. These opportunities are truly life-changing for many of these kids, and their families. Many of our #areuin? kids are







using the card for multiple activities...a membership at the Y, soccer at Exeter Rec in the fall and softball through EJBSL in the spring, for example.

The \$2,500 awarded by the Town of Exeter in FY24 directly supported the operating costs necessary to make the increased impact we had this past year. We would not have been able to support the 20% increase of participants, 33% increase in program partners and the scholarships awarded without your financial support. With no signs of slowing down (overall number of youth served this past year increased by 25%), we are again requesting \$2,500 for the FY26 from the Town of Exeter to help support the continued growth in kids served, scholarships provided and programs offered.

We have been fortunate enough to also continue to receive financial support from many Exeter-based supporters such as the Steve & Katy Singlar Foundation, the Bauman Foundation, the Acorn Alcinda Foundation, Meredith Village Savings Bank, Exeter Hospital, EGWFC, as well as many local individual donors this past year. The KEY Collective's deepest roots are here in Exeter, and we only expect those roots to grow stronger and deeper each year that we continue to expand.

Thank you very much for your time and consideration. We hope KEY Collective has an opportunity to partner with the Town of Exeter once again.
