



# 2024 SUMMER ADVENTURE CAMP

## Grades 1-7

Come join your friends and our amazing staff at the Exeter Parks & Recreation Department’s Summer Adventure Camp. Some of the activities will include: Daily Pool & Swim time, Games, Arts & Crafts, Music, Skits, Sports, and trips to places such as Water Country, Canobie Lake Park, Funtown USA, etc!

**AGES:** All registrants must be entering grade 1–7 for the 2024-2025 school year. Students are grouped by grade as of 9/1/2024. Note: Groups are: 1<sup>st</sup> – 2<sup>nd</sup>, 3<sup>rd</sup> – 4<sup>th</sup>, 5<sup>th</sup> and 6<sup>th</sup> – 7<sup>th</sup>. If your child is found to be in the wrong grade division, we reserve the right to cancel registration if child do not meet the grade requirement.

**SCHEDULE:** Summer Adventure Camp is an 8-week day camp beginning Monday, June 17, 2024, (pending Exeter School District’s last day of school) through Friday, August 9, 2024. S.A.C. is held Monday - Friday, 8:00a.m.-4:00pm at the Exeter Recreation Park on 4 Hampton Road. In the event of inclement weather, EPRD will notify families that camp is moved to the Tuck Learning Center (30 Linden St. Exeter, NH). To check on the status of camp, contact our Information Line to find out drop-off / pick-up location(s): **603-418-6495**. If camp is moved for the day, we will notify parents via email and by SMS text for those who have opted in through our registration software (RecDesk). Please note: **NO CAMP ON Wednesday, June 19 or Thursday, July 4, 2024.**

**REGISTRATION:** Returning resident campers may register between February 5-9, 2024 (EPRD staff will call you to register, please do not call unless you have not heard from us by February 9, 2024). Registration for residents will begin on February 12, 2024 and registration for non-residents will begin on February 20, 2024.

**NOTE:** At least one legal guardian must live in Exeter and show proof of residency (current utility bill, vehicle registration or tax bill). We may announce at any time during the registration that a cap, or limit, has gone into effect then a waiting list will be taken.

**FEE:** Payment must be made at time of registration. Please make your check payable to: E.P.R.D. Visa, MasterCard, Discover, Apple Pay & Google Pay accepted with a 3% service fee. There will be a \$20.00 fee charged for each returned check. Payment plans available for Exeter Residents. Limited Scholarships for residents available for those who have an AreUin card.

**FIELD TRIPS:** One field trip per week on weeks 2 through 7 (6 trips total) for each age group at an additional cost. The fee will provide bus transportation to a local attraction such as: Water Country, Wallis Sands or Canobie Lake Park. Field

trips must be paid in full for your child to participate. **Camp is not available if you choose not to send your child on that week's trip.** If your child will not be attending camp you are not required to pay the trip fee. **Weekly field trip fees are due one week prior to the field trip.** If there is space available, a \$20.00 late fee will be applied if registering for a trip after deadline.

**PICK-UP AND DROP OFF TIMES:** Staff is on duty from 8:00AM until 4:00PM. After care is from 4:00pm-5:30pm for \$10 per day. **A Staff member may request identification from the parent/guardian prior to leaving with a child.** The Exeter Parks & Recreation Department reserves the right to prevent any child from leaving the S.A.C premises until an adult is adequately identified. This ruling is in effect for your child's protection. **The S.A.C. Staff have been instructed to notify police upon an adult's refusal or inability to show proper identification.**

**WEATHER:** Camp is held rain or shine. We will notify parents if camp drop-off/pick-up is moved to our rain location by email and SMS text for those who opted in to receive text messages. If campers are moved to the Talbot gym due to weather, aftercare pickup will be located at the Exeter Parks and Recreation Department's office at 32 Court Street.

**MEDICATIONS:** It is required for parents of campers who require medication and/or have allergies to let the Recreation Department and staff aware prior to the first day of camp. After registration, parents will receive an email containing a link to complete a form for camp policies. **Every family must fill out this form, regardless of medication/allergies.**

**SICK/ABSENT:** It is not necessary to call the recreation office when keeping your child home sick.

**PLEASE SEND:** Labeling personal items is highly recommended. **SWIMSUIT, SUNBLOCK, TOWEL, ADDITIONAL CLOTHES, AND SNEAKERS.** We strongly recommended that your child come each morning with sunscreen applied. You must include a container in your child's bag for later applications by your child; Staff cannot apply sunscreen unless it is an aerosol spray sunscreen.

**STAFF:** The S.A.C. Staff are trained by EPRD staff and professional camp consultants to ensure a safe and fun camp experience. Staff are certified in first aid/CPR/AED training. Each member on our team has a special talent to share, making Summer Adventure Camp a fun and creative adventure for each camper!

**LUNCH/DRINKS/SNACKS:** (refrigeration not available) - All parents/guardians are responsible for providing their children with adequate and nutritional lunch and snack items. If possible, pack lunches in small cooler-style or insulated bags/boxes. We will be providing all campers with their own reusable water bottle in 2024! We have new water fountain/bottle filling stations to help reduce single use plastic.

**CONCESSION STAND:** If you would like your child to purchase lunch, snacks or drinks from the concession stand, please do not send them with more than \$5-\$10 dollars per day. EPRD, the Town of Exeter, their staff and representatives are not responsible for money missing or stolen within their programs or facilities. Children will be responsible for their own money.

**More information will be emailed before the start of camp. We're looking forward to another great summer!**
