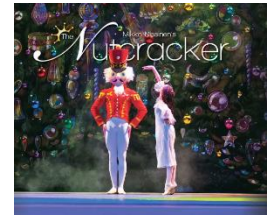




Boston Ballet's The Nutcracker

EVENT: Join Exeter Parks & Rec for Boston Ballet's The Nutcracker. Join Clara Silberhaus one magical Christmas Eve as she travels to the Kingdom of the Sweets. Along the way, experience the excitement of the dancing bear, the growing Christmas tree, the battle with the mice, and the Nutcracker who comes to life! The Nutcracker is based on the libretto by Alexandre Dumas père titled The Tale of the Nutcracker, which is adapted from E. T. A. Hoffmann's story The Nutcracker and the Mouse King. At Boston Ballet, The Nutcracker is so much more than a holiday show. This spectacular program includes some of the most technically challenging choreography in classical ballet. From the grand pas de deux to the enchanting snow scene, and the high-flying Russian dancers, the ballet includes stunning performances from every single dancer on stage. It also includes exciting performances of 83 students from the Boston Ballet School. Prior to the show, we will have lunch across the street from the theater at Legal Sea Foods Downtown Crossing.

DATE: The date selected is Wednesday, December 18, 2024. We will depart the Exeter Recreation Center parking lot at 10:00am and will be returning to Exeter at approximately 6:00pm.

FEE: The fee is **\$100.00 for residents and \$125.00 for non-residents**, which includes transportation in the Recreation Department Van, lunch and admission to the show.

DEADLINE: The deadline to register is Monday, November 18, or once the van is sold out.

Note: We need a minimum of 9 people registered. Max of 12 people.

REFUNDS: No refunds after the registration deadline unless we can find a replacement for your spot in the program. *

*Medical Injury/Illness Policy: If there is a medically documented injury/illness we will prorate a refund after we receive written medical varication from your physician which must be received prior to the trip.

Accessibility Guidelines: The EPRD van is not wheelchair accessible. While we are able to accommodate a range of mobility levels, all participants must be able to step up into the van and step out of the van on their own without assistance. All trips will be rated for accessibility. Please refer to the top of the flyer for the accessibility rating to determine if this trip matches your level of comfort with walking, stairs, and uneven ground.
