**AGES:** All registrants must be 4 years old by June 17, 2024 and potty trained without need of assistance using the bathroom.

**SCHEDULE:** Little Adventure Camp is an 8-week day camp beginning Monday, June 17, 2024, (pending Exeter School District's last day of school) through Friday, August 9, 2024. Little Adventure Camp is held Monday - Friday, 8:00a.m.-12:00pm at the Exeter Recreation Park on 10 Hampton Road. In the event of inclement weather, EPRD will notify families that camp is moved to the Tuck Learning Center (30 Linden St. Exeter, NH). To check on the status of camp, contact our Information Line to find out drop-off / pick-up location(s): **603-418-6495**. If camp is moved for the day, we will notify parents via email and by SMS text for those who have opted in through our registration software (RecDesk). Please note: **NO CAMP ON Wednesday, June 19 or Thursday, July 4, 2024.**

**REGISTRATION:** Returning Exeter resident campers may register between February 5-9, 2024 (EPRD staff will call you to register, please do not call unless you have not heard from us by February 9, 2024). Registration for Exeter residents will begin on February 12, 2024 and registration for non-residents will begin on February 20, 2024.

**NOTE:** **At least one legal guardian must live in Exeter and show proof of residency (current utility bill, vehicle registration or tax bill).** We may announce at any time during the registration that a cap, or limit, has gone into effect then a waiting list will be taken.

**FEE:** Payment must be made at time of registration. Please make your check payable to: E.P.R.D. Visa, MasterCard, Discover, Apple Pay & Google Pay accepted with a 3% service fee. There will be a \$20.00 fee charged for each returned check. Payment plans available for Exeter Residents. Limited Scholarships for residents available for those who have an AreUin card.

**POOL TIME:** On Tuesday's and Thursday's camp staff will bring Little Adventure Camp to the Town Pool to play on the splash pad. Campers will not be permitted to swim in the large pool during camp but are welcome to swim with a parent or guardian after camp. Campers must arrive to camp dressed in their swim suit on Tuesday's and Thursday's. Swim lessons are available on Monday's Wednesday's and Friday's for an additional cost (separate registration) and staff members will bring campers to and from their swim. Campers must come already dressed in their swim suit.

**PICK-UP AND DROP OFF TIMES:** Staff is on duty from 8:00AM until 12:15PM. *Extended care is not available* for Little Adventure Camp. All campers must be picked up no later than 12:15pm. **A Staff member may request identification from the parent/guardian prior to leaving with a child.** The Exeter Parks & Recreation Department reserves the right to prevent any child from leaving the S.A.C premises until an adult is adequately identified. This ruling is in effect for your child's protection. **The S.A.C. Staff have been instructed to notify police upon an adult's refusal or inability to show proper identification.**

**WEATHER:** Camp is held rain or shine. We will notify parents if camp drop-off/pick-up is moved to our rain location by email and SMS text for those who opted in to receive text messages. If campers are moved to the Talbot gym due to weather.

**MEDICATIONS:** It is required for parents of campers who require medication and/or have allergies to let the Recreation Department and staff aware prior to the first day of camp. After registration, parents will receive an email containing a link to complete a form for camp policies. **Every family must fill out this form, regardless of medication/allergies.**

**SICK/ABSENT:** It is not necessary to call the recreation office when keeping your child home sick.

**PLEASE SEND:** Labeling personal items is highly recommended. **SWIMSUIT, SUNBLOCK, TOWEL, ADDITIONAL CLOTHES, AND SNEAKERS.** We strongly recommended that your child come each morning with sunscreen applied and already dressed in their bathing suit. You must include a sunscreen in your child's bag for later applications by your child; Staff cannot apply sunscreen unless it is an aerosol spray sunscreen.

**STAFF:** The S.A.C. Staff are trained by EPRD staff and professional camp consultants to ensure a safe and fun camp experience. Staff are certified in first aid/CPR/AED training. Each member on our team has a special talent to share, making Summer Adventure Camp a fun and creative adventure for each camper! Out Little Adventure Camp staff to camper ratio is 1:6.

**DRINKS/SNACKS:** (refrigeration not available) - All parents/guardians are responsible for providing their children with adequate and nutritional snack items. If possible, pack snacks in small cooler-style or insulated bags/boxes. We will be providing all campers with their own reusable water bottle in 2024! We have new water fountain/bottle filling stations to help reduce single use plastic.

**CONCESSION STAND:** Little Adventure Campers are not permitted to purchase snacks from the concession stand during camp hours.

**More information will be emailed before the start of camp. We're looking forward to another great summer!**
