- Town. The Town will fund Swasey with \$3,600 via Warrant Article this year which will go 44
- back to maintenance. 45
- 46 Chair Staples indicated they were getting permitting fees and guarterly payments from the Trust in Ohio. 47
- Mr. Thompson raised concerns with the overage on the budget for electrical which is \$950 48 49 with costs over \$1,500 and the pavilion, which is owned by the Town, being used to generate electricity to event applicants. He questioned whether this could be offset somehow. Chair 50 Staples will ask Select Board Representative Papakonstantis at the March meeting. 51
