22 *Mr. Short motioned to approve the March 18, 2026 minutes. Mr. Thompson seconded the*  
23 *motion. A vote was taken, all were in favor, the motion passed unanimously 3-0-0.*

25 **April 15, 2026 Site Walk Minutes**

27 *Mr. Thompson motioned to approve the April 15, 2026 site walk minutes. Mr. Short*  
28 *seconded the motion. A vote was taken, all were in favor, the motion passed*  
29 *unanimously 3-0-0.*

31 **4. Coastal Resiliency**

33 Mr. Thompson reported that the final report will be at the joint meeting with the Select Board at a  
34 date to be determined. Mr. Short requested that a draft of the proposal be provided prior to that  
35 meeting.

37 **5. Sewer Project in Parkway**

39 Chair Staples indicated that he talked to Steve Dalton and the tanks are being pumped out.

41 **6. Pedestrians in road with two-way traffic**

43 Chair Staples reported there are issues with people walking in the middle of the road where  
44 there is two-way traffic and not moving out of the way so traffic can go. As a result words are

45 being exchanged and signs have been requested. Mr. Short noted people are not paying  
46 attention. Select Board Representative Papakonstantis asked how often this was happening  
47 and Chair Staples indicated that he knew of a couple of times. Chair Staples noted this pattern  
48 has been this way two years in November.

50 Select Board Representative Papakonstantis stated that he would talk to Melissa about getting  
51 the word out multiple ways on social media. Chair Staples indicated that the Trustees would try  
52 those avenues first but hate to put up signs for common sense.

56 Chair Staples indicated the event was well attended.

## 58 **8. Fence Estimates**

60 Mr. Thompson obtained two estimates from AAA fence for repair or replacement. The price to  
61 repair damaged sections with the same materials is \$3,800. The price for replacement with  
62 similar height and upgraded thickness to eight gauge is \$95,000. He noted that AAA fence  
63 questioned who owns the fence where the finished side is facing out because typically the  
64 property owners put the fence good side out but that may not be the case. Mr. Thompson will  
65 connect with Doug Eastman to see who owns the fence. Mr. Damsell stated that he believes  
66 the fence along the Parkway belongs to the Parkway.

68 Chair Staples questioned if AAA is the company the town uses or if there were records of  
69 expenditures. Mr. Thompson will ask Greg. Chair Staples indicated he did not think the fence  
70 needs to be replaced entirely.
