- Update on scholarships
  - Look at N.S. at the end of his junior year and how we may allocate funds to support him should he graduate early.

- Balance in checking account is high
- Erik Loranger is looking into Unitrust to see if it will produce more income that we as trustees can use for good; rather than leaving it in the traditional investment approach and only having the income accessible for us.
- Erik recommends we award \$3750/semester for an annual amount of \$7500/year in scholarships this spring to the class of 2021, relying on income from the investment account.
  - Total Revenue in last four years:
    - \$74400 in 2020
    - \$80014 in 2019
    - **\$75352** in 2018
    - \$70,895 in 2017
  - Unitrust approach would give us more income funds to draw from and work with.
    - We cannot pull principle in our current investment
  - Kate Miller motions to make an amendment to the Treasurer's report to change the funds we are allocating for scholarship from \$7500 per year to \$8500 annually (\$4250 per semester).
    - Jamie Sirois seconded the motion to amend the treasurer
      - All in favor (5 in person aye; Jane McCaffery aye via Zoom)
