\$55,378.89 as of 2/29/2024 with deposits of \$6,511.63 from the investment account and income from dividends & interest of \$210.26. Two scholarship checks were cashed for \$2,500.00 and there was a withdrawal of \$20,614.42 which was put into the investment account.

March:

\$65,510.51 as of 3/28/2024 with deposits of \$9,934.63 from the investment account and income from dividends & interest of \$196.99.

Investment Account:

February:

\$2,388,658.23 as of 2/29/2024 with a deposit of \$20,614.42 from the checkbook & income from dividends & interest of \$6,053.82 and a withdrawal to be put into the checkbook of \$6,511.63. There were no expenses and a change in value of +\$16,068.91.

5. Financial Report- Erik

- Financial Report
 - 2024 has started out well; 2023 ended strong
 - Inflation numbers are still rising; we are expecting a lot of ups and downs this year
 - o Rates may increase again
 - Geopolitical tensions are impacting investments
 - o Primary objective is to generate income for scholarships and grants
 - Trustees have incorporated socially responsible investment practices
 - We use Morning Star as a tool to identify socially responsible investments.
 - Current asset allocation
 - Bonds 40%
 - Stocks 60%
 - Trust fund is up 4%
 - We are generating \$65,000 income for scholarships and grants.
 - Out outlook for 2024 is a bit "WAIT AND SEE"
 - Watching around the globe and we will adjust accordingly.
 - Slow and steady is winning the race.
 - o Consumers are spending; credit card debt is at an all time high.
 - Average credit card rate is 28.9%.
 - Fed wants to cut rates to avoid a recession; that will probably need to wait until fall before a decision is made.
 - Inflation
 - Food and energy keeps going up.
 - Technology/AI
 - Investing in technology will provide huge growth but they don't pay dividends so we do not qualify for them to use them as an investment for our fund.
- Fees for Raymond James are paid quarterly to Raymond James.
 - o Once a year we credit back the account from the investments.
- 2024 Possible Award Amount
 - We could potentially go up to \$65,000 in scholarships and grants.
